

### RULES FOR PARTICIPATION IN THE I'MNOVATION COMPETITION

### Objective

The object of these rules is to regulate participation in the "*I'MNOVATION Competition*" (the "**Competition**") held by ACCIONA, S.A. ("**ACCIONA**").

The aim of the Competition is to develop a technical solution for the postprocessing of point clouds to obtain models of pre-existing, constructed geographic elements (the "**Challenge**", as defined in more detail in the following section). It can involve software, applications, webs, systems or a combination of the same.

At the start of the Competition, the start-ups participating will be given a file with an example of the point cloud so that they can develop their solution to the Challenge. This file will be available on the website <u>open.imnovation.com</u> where it can be downloaded and processed by the start-ups participating.

# The Challenge

#### Postprocessing of point clouds to obtain models of pre-existing, constructed geographic elements

Use of laser scanner tools to obtain 3D models using point clouds is undergoing intense growth in the construction and civil engineering sector. However, the processing of the information obtained continues to be slow, manual and incomplete despite the new developments appearing on the market. The upshot of this is that the point cloud information is a mere visual register with scant parametric and analytical value.

At ACCIONA, we are looking for start-ups who propose a system/work flow for postprocessing information from 3D captures. How do we advance towards the conversion of "raw data" into "smart data" eliminating repetitive tasks with no added value derived from the processing tasks of cleaning, adjusting, file segmentation, etc.? How do we obtain benchmark geometries via point clouds enabling us to create 3D and BIM models?

#### **Requirements for participating**

Those start-ups that meet the following requirements can participate in the Competition:

- Be a start-up that has been incorporated in the last five years. The start-ups, domestic or international, will offer proposals, approaches, solutions and ideas that can offer a response to the Challenge.
- The developer of the project must be a natural person, of legal age and with the legal capacity to assume obligations.
- The company proposing the solution to the Challenge must be legally incorporated and not in a situation of mandatory winding-up.
- The developers of the project will not have been convicted, by a final judgment, of intentional offences, where the criminal liability has not expired.



 Acceptance of these rules of the Competition (the "Rules") set out for consultation and download at open.imnovation.com (the "Platform") placed at the disposal of the participants.

Those participants that fail to meet any of these criteria, either before admission or subsequently, may be excluded from the Competition, losing any option of receiving a prize and with no right to claim anything from ACCIONA for any reason.

The data that the participants supply when registering for the Competition must be accurate and any participants supplying incorrect or incomplete data will lose any option of participating in the Competition.

ACCIONA reserves the right not to accept or to remove from the Competition, without prior notice, all those participants that it finds to be acting in a fraudulent or abusive manner or contrary to the spirit of the Competition or the law, to third-party rights and/or to good faith. Likewise, ACCIONA may remove any participant or related person whose conduct is inconsistent with ACCIONA's reputation or good name.

None of the above actions will entitle any participant or potential participant to claim damages, expenses, etc.

#### Prize

The participant presenting the best solution to the Challenge will receive a price of 5,000 EUR (the "Prize").

### Presentation of candidacies and term

Start-ups who wish to participate in the Competition will log on and accept the Rules via the following URL: <u>open.imnovation.com</u> (the "**Users**").

They will be able to see the Challenge and propose a solution by clicking on the button "Accept the Challenge".

The solution will be considered presented when all obligatory fields have been completed and the button "*Publish*" is clicked.

These fields are:

- How would you resolve the Challenge?
- Why do you feel this solution is better than others?
- What do you expect from forming part of the I'MNOVATION ecosystem?
- Other documentation that is relevant to assess the candidacy.

The **term for presenting solutions** will start on 8 September at 12.00 a.m. and end on 20 October at 11.59 p.m. (Central European Time). Any solutions presented after the expiry of the term will not be accepted in the Competition, even if they remain on the web. All solutions presented during the term established above will be admitted.

ACCIONA reserves the right to reject those solutions that are incomplete, improperly completed, do not comply with the requirements for participation established above or that fail to comply with or infringe any applicable regulations.



Moreover, the User represents that (i) the solutions are original and, as such, have not been produced or created by non-participant third persons, or (ii) where applicable, it holds the pertinent authorisations for presentation. In this regard, the User agrees to hold ACCIONA harmless against any third-party claim derived from the above.

ACCIONA will not be liable for possible faults or malfunction of the web page containing the form.

## Process of assessment

The coordination and management of the Competition will be carried out by ACCIONA. The process of assessment will be carried out by Acciona Construcción, S.A. (a company belonging to the ACCIONA Group) and will start when the Competition starts and the term for presentation of solutions has concluded.

#### Decision

The finalist companies will be invited to participate in the "Selection Day" to be held at the head offices of ACCIONA in Spain.

The "Selection Day" consists of a day on which the finalist companies will present their proposed solutions to the Challenge, to a selection panel that will assess the solutions proposed based on criteria such as innovation, cost and impact on business.

## Industrial and intellectual property

Ownership of all industrial and/or intellectual property rights created by the participant start-ups, will be held by the selected start-ups, who will be the sole, exclusive owners of the technologies created in the context of their participation in the Competition.

The presentation of solutions does not imply the assignment of any industrial or intellectual rights.

The participants undertake to hold ACCIONA harmless in relation to any third-party action for damages derived from any of the projects presented or the use of the same by ACCIONA in the event it infringes intellectual or industrial property rights, or represents unfair competition or a violation of any other applicable legislation. ACCIONA does not assume any liability, whether direct or indirect, regarding any kind of disagreement, dispute and/or lawsuit that may derive from the publication, disclosure and/or dissemination of the projects via the programme without the mandatory consent of their lawful owners. Likewise, ACCIONA does not assume any liability for non-compliance with any rule or for any infringement of third-party rights by the participants by means of their participation in the Competition, the latter assuming the obligation to hold ACCIONA harmless in that case.

#### Taxation

The Prize awarded in this Competition will be subject, as applicable, to the Personal Income Tax Act (*Ley 35/2006 de 28 de noviembre por la que se aprueba el Impuesto sobre la Renta de las Personas Físicas*) which partially amends the Corporation Tax Act and the Non-Resident Income Tax Act and the Wealth Tax Act (IRPF); Royal Decree 439/2007, which approves its Regulations and subsequent amendments; Legislative Royal Decree 5/2004, of 5 March, which approves the Restated Text of the Non-Resident Income Tax Act (IRNR); Royal Decree 1776/2004, of 30 July, which approves the Regulations of the Non-Resident Income Tax Act.



In accordance with the regulations indicated, prizes awarded as a result of participation in games, competitions, raffles or random combinations, whether or not linked to the offer, promotion or sale of certain goods, products or services, are subject to withholding or payment on account wherever the value of the prize exceeds 300 euros, as it is a capital gain.

Likewise, in the event the recipient is resident for tax purposes in a country other than Spain, the amount of the Prize may be subject to payment on account under IRNR or, in the event a double taxation treaty signed by Spain exists, the terms of such treaty will apply. ACCIONA, S.A. will be responsible for making the corresponding payment on account or withholding, for IRPF or IRNR, and the recipient will be responsible for declaring the corresponding capital gain in its IRPF declaration or that of the equivalent tax that applies in its country of residence.

In any event, any tax repercussions of receipt of the Prize for the recipient will be borne by it.

### Acceptance of the Rules

By registering for the Competition, the participant accepts the terms contained in these Rules, as well as any resolutions and decisions adopted by ACCIONA in the context of the Competition in full and without any reservations or conditions.

ACCIONA reserves the right to modify the content of these Rules at any time, publicly announcing any such modifications/updates via the Platform.

#### Personal data protection

In accordance with EU Regulation 2016/679 on Data Protection and other relevant provisions, you are informed that your personal data will be processed by Acciona, S.A., with Tax ID number: A-08001851; address: Avenida de Europa, no. 18, 28108, Alcobendas (Madrid); Telephone: 91.663.28.51; Data Protection Department: protecciondedatos@acciona.com; for the purpose of managing your potential participation in the Competition, as well as in future programmes and other possible collaboration opportunities. The legal basis for the data processing is the consent granted when supplying the data. If you fail to supply the necessary data, your application cannot be accepted. The data will be stored for as long as the relationship is maintained unless erasure of the same is requested.

Your data may be assigned to other ACCIONA Group entities (a list of which can be obtained in the report from the last consolidated accounts of Acciona, S.A., <u>www.acciona.com/es/accionistas-</u> <u>inversores/informacion-financiera/cuentas-anuales/</u>). Likewise, Acciona, S.A. informs you that, in order to achieve the objectives mentioned, it uses computer applications and other services from third-party providers. Some of these applications and providers and ACCIONA Group entities may be located outside of the European Union (EU), including countries in which the legal level of data protection is not comparable to the level of data protection applied within the EEA, representing a possible international transfer of data. # Confidentiality

The User undertakes to maintain the confidentiality of all information to which it has access via the Platform. Consequently, the User understands that it is information that must not be disclosed.

The point cloud file made available to the participants by ACCIONA on the <u>open.imnovation.com</u> platform will be treated as confidential material and participants will not inform third parties of the same or transfer it to them, or commercially exploit it either themselves or via others.

However, this confidentiality obligation will cease as soon as ACCIONA makes the information public or it becomes public for reasons not attributable to the User.
